

## Using the College's Public Register

According to section 33 of the *Health Professions Act* (HPA), the Alberta College of Medical Diagnostic and Therapeutic Technologists (ACMDTT or 'the College') must maintain a public register of all regulated members (registrants) and previous non-regulated members.

The HPA and the ACMDTT's bylaws set out the information required on the public register, including a registrant's legal name, practice name, ACMDTT registration number, join date, registration type, registration status, conduct history, registration effective and expiry date, specialty, restrictions and conditions, and any advanced and enhanced practice authorizations.

### Searching

The public register can be accessed through the College's website ([acmdtt.com](http://acmdtt.com)) by clicking on the "Public Register" button.

The public can search for medical radiation technologists (MRTs) and electroneurophysiology technologists (ENPs) by first name, last name and/or registration number.

### Understanding Search Results

Legal Full Name	The registrant's legal first and last name.	
Practice Name	The name that the registrant uses to identify themselves within their practice.	
Registration Type	The registrant's current type (category) of registration.	
	• General	A registrant on the general register who is entitled to practice the profession.
	• Temporary	A registrant on the temporary register who is entitled to practice the profession. These registrants must be supervised by a regulated member when performing restricted activities.
	• Courtesy	A registrant on the courtesy register who is entitled to temporarily practice the profession in Alberta, usually for a maximum of six months.
Status	The registrant's current registration status.	
	Active	A registrant who is in good standing.
	Suspended	<p>A registrant whose practice permit has been suspended. <b>The registrant is not entitled to practice when their practice permit is suspended.</b></p> <p>There are several reasons why a practice permit can be suspended:</p>

	<ul style="list-style-type: none"> <li>• Suspended (Administrative)</li> </ul>	A registrant who has had their practice permit suspended for administrative reasons, which may include failure to complete renewal, non-payment of registration fees, non-compliance with the Continuing Competence Program (CCP), or lack of professional liability insurance. The registrant is not entitled to practice while their practice permit is suspended.
	<ul style="list-style-type: none"> <li>• Suspended (Sexual Abuse)</li> </ul>	A registrant who has had their practice permit suspended due to unprofessional conduct based on sexual abuse.
	<ul style="list-style-type: none"> <li>• Suspended (Sexual Misconduct)</li> </ul>	A registrant who has had their practice permit suspended due to unprofessional conduct based on sexual misconduct.
	<ul style="list-style-type: none"> <li>• Suspended (Unprofessional Conduct)</li> </ul>	A registrant who has had their practice permit suspended due to unprofessional conduct.
	Cancelled	A registrant whose practice permit has been cancelled. <b>The registrant is not entitled to practice when their practice permit is cancelled.</b>
	<ul style="list-style-type: none"> <li>• Cancelled (Administrative)</li> </ul>	A registrant who has had their practice permit cancelled for administrative reasons, which may include failure to complete renewal, non-payment of registration fees, non-compliance with the Continuing Competence Program (CCP) non-compliant, non-payment of registration fees, or lack of professional liability insurance.
	<ul style="list-style-type: none"> <li>• Cancelled (Sexual Abuse)</li> </ul>	A registrant who has had their practice permit cancelled due to unprofessional conduct based on sexual abuse.
	<ul style="list-style-type: none"> <li>• Cancelled (Sexual Misconduct)</li> </ul>	A registrant who has had their practice permit cancelled due to unprofessional conduct based on sexual misconduct.
	<ul style="list-style-type: none"> <li>• Cancelled (Unprofessional Conduct)</li> </ul>	A registrant who has had their practice permit cancelled due to unprofessional conduct.
	<ul style="list-style-type: none"> <li>• Cancelled - Registration</li> </ul>	A registrant who has had their practice permit removed due to administrative reasons, such as leaving the province, retirement, resignation, death or other reasons. <b>The registrant is not entitled to practice while their practice permit is removed from the register.</b>
	Expired	A non-registrant whose membership has expired due to non-renewal.
	Withdrawn	A non-registrant who has had their membership rescinded due to College bylaw changes
ACMDTT #	The registrant's unique registrant number.	

Conduct History	<p>The registrant's conduct history, all orders of the College during a professional conduct investigation, and orders of the hearing tribunal pursuant to s.82(1) of the HPA. This includes, but is not limited to:</p> <ul style="list-style-type: none"> <li>• Cautions and specified continuing education or remediation programs ordered;</li> <li>• Conditions imposed on the registrant's practice permit;</li> <li>• Information related to current and past hearing tribunal decisions related to unprofessional conduct;</li> <li>• Information related to any known current criminal convictions, criminal charges and bail conditions, including charges and convictions of sexual abuse and sexual misconduct;</li> <li>• Findings of malpractice;</li> <li>• Unprofessional conduct in another jurisdiction.</li> </ul>
Join Date	The date the registrant initially registered with the College and was granted a practice permit.
Effective and Expiry	The date the registrant's <b>current practice permit</b> became effective and the date it expires. This section does not identify registration year after year.
Specialties	Identifies which of the five specialties regulated by the College the registrant is authorized to practice. The specialties include nuclear medicine, radiation therapy, magnetic resonance imaging, radiological technology and electroneurophysiology.
Conditions and Restrictions	Identifies any administrative or conduct-related conditions placed on a registrant's practice. These conditions include but are not limited to supervision, practice permit limitations and/or regular reporting. This section also includes restrictions placed on a registrant's practice permit.
Advanced and Enhanced Practice Authorizations	This section identifies enhancements and/or authorizations granted by the College to registrants who may provide a restricted activity that registrants generally do not provide. This includes, but is not limited to, venipuncture, medication administration, breast and bladder ultrasound, etc.

## Disclosure

There are circumstances under which a regulated or non-regulated member of the College may not have the above information on the public register. For example, if the Registrar has reasonable grounds to believe that divulgence of the information could lead to safety concerns for the regulated or non-regulated member, the Registrar will withhold the information as required.
